This Amendment No. 2 (this "Amendment") to Schedule 13G (the "Schedule 13G") is being filed on behalf of Nokomis Capital, L.L.C., a Texas limited liability company ("Nokomis Capital"), and Mr. Brett Hendrickson, the principal of Nokomis Capital, relating to Common Stock, par value \$0.01 per share (the "Common Stock"), of inTEST Corporation, a Delaware corporation (the "Issuer").
