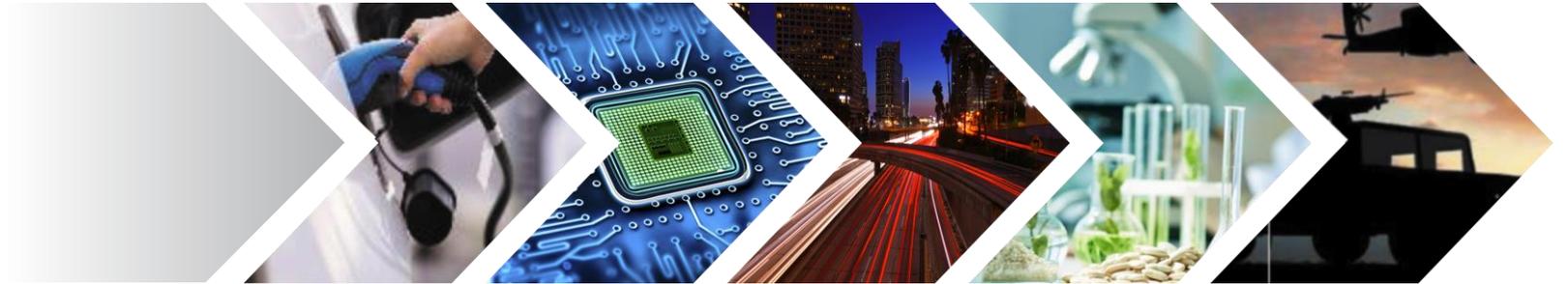

Non-GAAP Financial Measures and Forward-Looking Non-GAAP Financial Measures

In addition to disclosing results that are determined in accordance with GAAP, we also disclose non-GAAP financial measures. These non-GAAP financial measures consist of adjusted net earnings, adjusted earnings per diluted share (adjusted EPS), adjusted EBITDA, adjusted EBITDA margin and free cash flow. The Company defines these non-GAAP measures as follows:

- Adjusted net earnings is derived by adding acquired intangible amortization, adjusted for the related income tax expense (benefit), to net earnings (loss).
- Adjusted earnings per diluted share (adjusted EPS) is derived by dividing adjusted net earnings by diluted weighted average shares outstanding.
- Adjusted EBITDA is derived by adding acquired intangible amortization, net interest expense, income tax expense, depreciation, and stock-based compensation expense to net earnings.
- Adjusted EBITDA margin is derived by dividing adjusted EBITDA by revenue.
- Free cash flow is derived by subtracting capital expenditures from net cash provided by or used in operating activities.

These results are provided as a complement to the results provided in accordance with GAAP. Adjusted net earnings and adjusted earnings per diluted share (adjusted EPS) are non-GAAP financial measures presented to provide investors with meaningful, supplemental information regarding our baseline performance before acquired intangible amortization charges as management believes this expense may not be indicative of our underlying operating performance. Adjusted EBITDA and adjusted EBITDA margin are non-GAAP financial measures presented primarily as a measure of liquidity as they exclude non-cash charges for acquired intangible amortization, depreciation and stock-based compensation. In addition, adjusted EBITDA and adjusted EBITDA margin also exclude the impact of interest income or expense and income tax expense or benefit, as management believes these expenses may not be indicative of our underlying operating performance. The non-GAAP financial measures presented in this presentation are used by management to make operational decisions, to forecast future operational results, and for comparison with our business plan, historical operating results and the operating results of our peers. Reconciliations from net earnings and earnings per diluted share (EPS) to adjusted net earnings and adjusted earnings per diluted share (adjusted EPS) and from net earnings and net margin to adjusted EBITDA and adjusted EBITDA margin, are contained in the tables below. Each of our non-GAAP measures have limitations as analytical tools. They should not be viewed in isolation or as a substitute for U.S. GAAP measures of earnings or cash flows. Limitations may include the cash portion of interest expense, income tax (benefit) provision, charges related to intangible asset amortization and stock-based compensation expense. These items could significantly affect our financial results. Management believes these Non-GAAP financial measures are important in evaluating our performance, results of operations, and financial position. We use non-GAAP financial measures to supplement our U.S. GAAP results in order to provide a more complete understanding of the factors and trends affecting our business. Adjusted net earnings, adjusted earnings per diluted share (adjusted EPS), adjusted EBITDA, and adjusted EBITDA margin are not alternatives to net earnings, earnings per diluted share or margin as calculated and presented in accordance with U.S. GAAP. As such, they should not be considered or relied upon as substitutes or alternatives for any such U.S. GAAP financial measure. We strongly urge you to review the reconciliations of adjusted net earnings, adjusted earnings per diluted share (adjusted EPS), adjusted EBITDA, and adjusted EBITDA margin along with our financial statements included elsewhere in this presentation. We also strongly urge you not to rely on any single financial measure to evaluate our business. Key Performance Metrics

In addition to non-GAAP measures, management uses the following key performance metrics to analyze and measure the Company's financial performance and results of operations: orders and backlog. Management uses orders and backlog as measures of current and future business and financial performance, and these may not be comparable with measures provided by other companies. Orders represent written communications received from customers requesting the Company to provide products and/or services. Backlog is calculated on the basis of firm purchase orders we receive for which revenue has not yet been recognized. Management believes tracking orders and backlog are useful as it often times is a leading indicator of future performance. In accordance with industry practice, contracts may include provisions for cancellation, termination, or suspension at the discretion of the customer. Given that each of orders and backlog are operational measures and that the Company's methodology for calculating orders and backlog does not meet the definition of a non-GAAP measure, as that term is defined by the U.S. Securities and Exchange Commission, a quantitative reconciliation for each is not required or provided.

Execution of 5-Point Strategy Driving Results

- Record quarterly revenue of \$32.6 million, up 10% y/y
- Q2 net earnings of \$2.8 million, up 32% y/y
- Continued execution of 5-Point Strategy for Growth
 - Driving y/y growth in sales, operating income, net earnings and Adjusted EBITDA (Non-GAAP)⁽¹⁾
 - Executing to expand market presence, develop new products, and increase aftermarket support
 - Pursuing acquisition targets to enhance product offerings, expand addressable markets, and deepen presence in served industries
- Successfully completed \$20 million At-The-Market equity offering
- Q2 orders⁽²⁾ up 2% sequentially with notable strength in security, defense/aerospace, automotive/EV, industrial and other markets
- Q2 backlog⁽²⁾ was \$44.6 million, down 2.5% sequentially




- Record Q2 revenue of \$32.6 million, up \$3.0 million, or 10.1% y/y
- Strong demand across most markets and technology offerings
 - Continued strong shipments in front-end semi related to Silicon Carbide (SiC) crystal growth and epitaxy investments
 - Ongoing back-end semi demand for solutions serving the mixed-signal and analog integrated circuit production testing
 - Defense/aerospace demand for thermal test solutions
 - Security demand for industrial grade image capture technology
- Q2 revenue at upper end of guidance range

(\$ in millions)


Quarters


- TTM gross profit increased \$5.6 million vs. 2022



(\$ in millions, except per share data)


EPS and Adjusted EPS (Non-GAAP)⁽¹⁾





➤ Q2 orders up 2% sequentially

- Strength in orders from security, defense/aerospace, automotive/EV, industrial and other markets
- Chillers for testing and production of high-powered traction inverters used in EVs
- Induction heating solutions as an environmentally preferred technology in many industrial applications

➤ Q2 2022 benefitted from customers securing production capacity resulting in record orders

➤ Backlog down 3.1% y/y and 2.5% sequentially

➤ Approximately 45% of backlog is expected to ship beyond Q3 2023





Driving Scale to Deliver Growth in Earnings




Division Operating Income⁽¹⁾

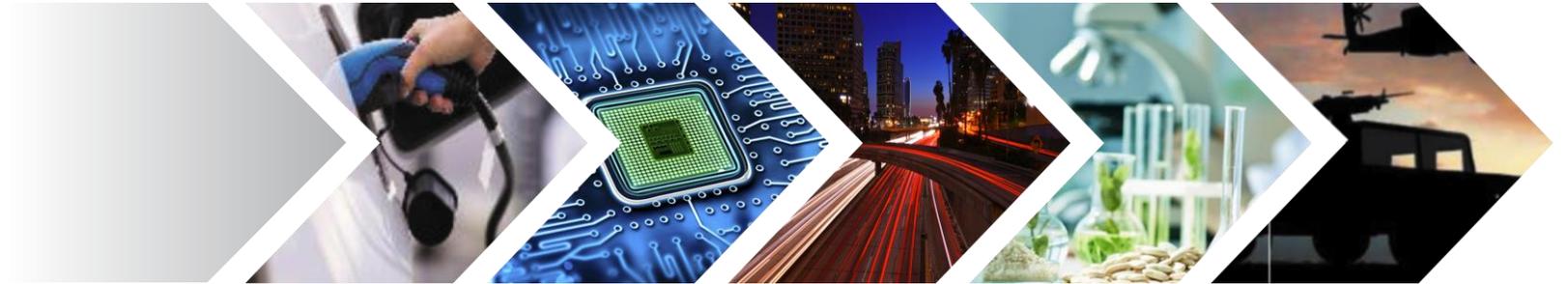
